June 2, 6pm: Opening with “Meet the Artists” FIRSTfriday of Falls Church reception, 6-8pm.
June 30: All unsold works must be picked up between 10am-6pm.

Three entries per artist, entry fee (nonrefundable): \$10 for the first work; \$5 for second and third entries, payable to Art and Frame of Falls Church.

Eligible media: Original works in all media are eligible and must be suitably prepared for installation. Maximum dimensions are 5' X 8' and maximum weight is 50 pounds.

Each submitted work must have the following information on a 3"x5" card, presentable for display: the artist's name, title of work, medium, price of work, and a short one sentence or phrase statement about the work as it relates to the theme. Works must be framed and/or finished in a neat, professional manner suitable to the medium. Hanging works must have hanging wire; no saw tooth hangars accepted. Art and Frame of Falls Church has the right to refuse to display any artwork it deems inappropriate for any reason. Submitted works must be accompanied by the fee(s) and this completed entry and release of liability statement.

Sale of work: All work must be for sale. All transactions will go through Art and Frame of Falls Church with The Tinner Hill Heritage Foundation receiving a 10% donation from each sale. Checks will be written to each artist by June 30th for sold items, 90% of each item. Unless sold, works must remain on display for the duration of the show.

Prizes: There will be cash prizes for 1st - \$200; 2nd - \$130; and 3rd - \$85.

Release of Liability Statement:

I the undersigned agree that Art and Frame of Falls Church has been given permission to display my artwork at 205 W.
